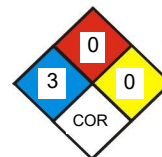

GHS LABEL H314 - Causes severe skin burns and eye damage.

ELEMENTS: P260 - Do not breathe dust/fume/gas/vapours/spray.

P264 - Wash exposed skin thoroughly after handling.

P280 - Wear protective gloves/clothing/eye protection/face protection.

P301+P330+P331 - IF SWALLOWED: Rinse mouth. Do NOT induce vomiting.
